These terms and conditions outlines the rules and regulations for booking, payment, cancellations & refund trough Native Snowboard adventures.

#### Booking and payment:

To secure your spot at one of our trips you have to pay the trip in full total trough our webpage. First then you will get your confirmation email direct after checking out and paying your trip. Feel free to contact us if you need more time to make the payment so we can hold your spot or you need more information about your trip before booking online.

#### Cancellations and Refunds :

If you need to cancel your trip this will have to be done 30 days prior to the trip start date to get a full refund of your trip.

No refunds are payed if you don't show up on your trip.

If cancellation is done before 24 hours after the booking of your trip you will get a full refund.

Everyone who is booking our trips needs to have their own travel insurance with trip cancellation security incase they get sick before or during the trip.

All our package trips must have a minimum of 5 people signed up 30 days prior to the start date of the trip or we can legally cancel the trip.

If the trip is canceled you off course get a full refund of your trip and will know it's been canceled minimum 30 days prior.
