These terms and conditions outlines the rules and regulations for booking, payment, cancellations & refund trough Native adventures No.

Booking and payment:

We recommend to book and pay your trips online trough our website. But you can also contact us for booking or request a invoice.

To secure a spot at one of our trips or courses you have to pay the trip in full total trough our website or via invoice.

Immediately after you have paid, you will receive an e-mail confirmation for your trip.

Feel free to contact us if you have questions or need more info about your trip before booking.

Cancellations and Refunds :

If cancellation is done before 24 hours after the booking of your trip you will get a full refund.

If you need to cancel your trip before 30 days to the start date of the trip, you will get a 50% refund.

If you need to cancel your trip within 30 days before start date of the trip, you will get no refund.

No refunds are payed if you don't show up on your trip.

All refunds will still have a transaction fee.

Everyone booking our trips must have their own travel insurance with trip cancellation insurance security incase they need to cancel their trip or something unforeseen should happen during the trip.

All our pre scheduled trips & course dates must have a minimum of 5 people signed up 30 days before the start date or we can legally cancel the trip.

If the trip or course are canceled, you will off course get a full refund and will be contacted about the cancellation at least 30 days before the start date.
